## Secondary Teachers' Membership Application/Renewal 2019

Application for membership is welcomed from all. Membership extends from 1st February to 31st January of the following year. The following options are available in 2019:

- ◆ **Metropolitan and Country Individual Membership** when paid personally by the individual;

This type of Membership can cover **1 or more teachers @ \$90.00 (+GST) for EACH Metro Teacher, or \$67.50 (+GST) for EACH Country Teacher.** For Individual (Country) and Institution (Country) memberships, 'Country' is defined as: "All places/localities within the following WA Government Educational Districts, Goldfields, Kimberley, Mid-West, Pilbara, South-West and Wheatbelt".
- ◆ **Corporate Membership**, at the discretion of the GAWA Council, may be extended to a Business Organisation or a Professional Association.
- ◆ **Student Membership** is available to a teacher education student enrolled full/part-time at any tertiary institution.
